

DEAR RESIDENTS,

YOU MAY PERHAPS BE AWARE THAT, AFTER HAVING BEEN DEFEATED IN THE LAST GENERAL BODY ELECTION, MAJOR GEN. V.K. SRIVASTVA (RETD.), MR. ANIL KHANNA, COL. TEJ K. TIKOO, MR. P.K. SHARMA, LT. COL. P.C. SHARMA, MR. VINOD KUMAR SHARMA, MR. ROHTASH CHAUHAN AND MR. K.S. PATHAK ALONG WITH 24 OTHER RESIDENTS, SOME OF WHOM ARE NOT EVEN OUR BONAFIDE MEMBERS, MADE A COMPLAINT TO THE DY. REGISTRAR FIRMS, SOCIETIES, AND CHITS, MEERUT, SEEKING THE FOLLOWING RELIEFS:-

- 1. ORDER THE DISMISSAL OF PRESENT EXECUTIVE COMMITTEE.**
- 2. HOLD ELECTIONS OF THE EXECUTIVE COMMITTEE FOR THE YEAR 2009-2010 IN ITS SUPERVISION.**
- 3. THE INCOME AND EXPENDITURE ACCOUNT OF THE ASSOCIATION BE SCRUTINIZED AT ITS OWN LEVEL.**
- 4. ORDER THE TENURE OF THE EXECUTIVE COMMITTEE TO ONE YEAR AND THE MAXIMUM NUMBER OF EXECUTIVE MEMBERS TO ELEVEN ONLY.**

ANOTHER COMPLAINT WAS LODGED BY THE THEN TREASURER, MR. B.B. AGGARWAL, ALLEGING THEREIN THAT HE WAS REMOVED FROM THE POST OF TREASURER, IN AN ILLEGAL MANNER BY FORCING HIM TO TENDER HIS RESIGNATION.

THE LD. DY. REGISTRAR AFTER HEARING BOTH THE PARTIES, ON FIVE SITTINGS, GAVE THE FOLLOWING FINDINGS:-

- 1) THE MAXIMUM NUMBERS OF EXECUTIVE MEMBERS IN TERM OF RULE 4(1) OF THE SOCIETY BYE LAWS, AT THE TIME OF ITS RENEWAL, ARE SHOWN AS 11. HENCE THERE CAN BE MAXIMUM 11 MEMBERS IN THE EXECUTIVE COMMITTEE. THE AMBIGUITY IN WORDS UNDER RULE 6 (1) CAN BE RECTIFIED IN THE GENERAL BODY MEETING BY MAKING AMENDMENTS, AS PER LAW. THE APPOINTMENT OF 6 NOMINATED MEMBERS TO THE EXECUTIVE COMMITTEE IS NOT LEGAL.**
- 2) THE VARIOUS AMENDMENTS CARRIED OUT IN THE GENERAL BODY MEETING, HELD ON 11-05-2008, ARE PROPER, HENCE APPROVED BY THIS OFFICE.**
- 3) SINCE MR. B.B. AGGARWAL HAS BEEN ELECTED BY THE GENERAL BODY, HE SHALL REMAIN THE MEMBER OF THE EXECUTIVE BODY TILL THE TIME HE IS REMOVED BY THE GENERAL BODY ITSELF. HOWEVER IT SHALL NOT BE JUSTIFIED TO ALLOW HIM TO HOLD THE OFFICE OF TREASURER, TILL AN INDEPENDENT AUDIT FOR THE YEAR 2008-2009 IS DONE BY THIS OFFICE, ITSELF.**

ORDER

IN VIEW OF THE FACTS STATED ABOVE, ITS ORDERED THAT THE EXECUTIVE COMMITTEE SHALL HAVE 11 MEMBERS. THE AMENDMENTS ARE APPROVED; HENCE THE ELECTION FOR A PERIOD OF 2 YEARS IS ALSO APPROVED. THE COMPLIANCE OF THE ORDERS BE INTIMATED TO THIS OFFICE.
