### **ELECTRIC WIRES IN 'C' BLOCK**

Complaints were being received from "C" Block residents about the damaged electric cables. There have been cases of fire and damage to parked vehicles. RWA took up the matter with the concerned authority on priority basis. Now this has been approved and cables will soon be replaced.

### **SECURITY**

Security of the sector has been engaging the attention of the committee. This is a collective responsibility and we should all co-operate to see that our sector remains peaceful and secured. In this connection we would like to make an earnest appeal to all the residents to kindly adhere to the following guidelines:

1. Get your car entered at the exit/entry gate as it is in your own interest.
2. Park your vehicle in such a way that metalled portion of the Road remains free for smooth flow of traffic as recently in case of fire the fire-brigades had faced lot of difficulty to reach the fire place. **GEAR LOCK IS A MUST.**
3. Do not rent out your house/keep domestic help without proper verification.
4. Do not keep your house unattended and keep a personal Guard whenever you go out.
5. Please entertain only those Venders/Dhobis who have been authorized by RWA.

Security Guards are deployed to look after our security. It is therefore requested that the residents may kindly co-operate to enable them to perform their duties without any problem.
