### SECURITY

Security is a sensitive matter and needs collective efforts to tackle the problem. Hence there is an urgent need of co-operation from all the residents to fight this common problem. The following guidelines may please be strictly adhered to:-

1. Never leave your house unattended and hire a personal guard whenever you plan to go out.

2. Park your vehicles in such a way that matalled portion of the road remains free for smooth flow of traffic. Kindly use Gear Lock and RWA sticker. It is reported by Group 4 Security that lot of cars are found unlocked during night hours. Kindly take care and see that the vehicles are properly locked.
3. Never Park your car in front of sector gates as it creates obstruction in case of emergency.
4. Be vigilant and inform appropriate authority in case of any unfortunate incident.
5. Get your servant/tenant verified and never entertain any unidentified person.
6. Guest Houses/PGs are creating a great security risk. Kindly cooperate.

You might have read about the gang of car thieves in today's paper. There is an urgent need to be vigilant and strictly follow the guidelines being circulated by RWA from time to time so that our sector remains free from such unfortunate situation.
